1. Definitions

- “**Company**” refers to ToraFX and its affiliates.

12. Modifications to the Terms

We reserve the right to revise these Terms at any time. Continued use after changes are posted constitutes acceptance of those changes. It is your responsibility to review the Terms periodically.

13. Jurisdiction and Governing Law

These Terms shall be governed by and construed in accordance with the laws of the **Union of the Comoros**, without regard to its conflict of law principles.

You agree that any legal action, dispute, or proceeding arising out of or relating to these Terms or your use of the Platform shall be exclusively submitted to the competent courts of the **Union of the Comoros**, and you hereby irrevocably consent to the jurisdiction and venue of such courts.



14. Abusive Trading Practices

14.1 The Company strictly prohibits all forms of abusive trading behavior. This includes, but is not limited to, the following activities:

- **Arbitrage Trading:** Including latency arbitrage, triangular arbitrage, or any form of pricing manipulation that exploits time delays or price feed discrepancies.
- **High-Frequency Trading (HFT):** Execution of trades using automated or high-speed systems designed to exploit platform inefficiencies.
- **Bonus Abuse:** Any attempt to meet bonus withdrawal conditions through unnatural or manipulative trading behavior, including circular trading or collusion between accounts.
- **Exploitation of Technical Vulnerabilities:** Use of software, bots, or systems designed to exploit errors or weaknesses in the trading platform or pricing system.
- **Any Other Abusive Strategy:** Any trading pattern or practice—whether known or not yet formally categorized—that contradicts fair usage principles or aims to gain unfair financial advantage.

14.2 The Company reserves the right, at its sole discretion, to investigate and determine whether any trading activity constitutes abusive behavior. In such cases, the Company may:

- **Withhold or cancel profits and bonuses,**
- **Reject any withdrawal request related to such activity,**
- **Terminate or suspend the account, and**
- **Take legal or regulatory action where applicable.**

14.3 Any account found to be involved in such practices **will not be approved for payout**. By opening an account with the Company, the Client acknowledges and agrees to these terms.


15. Entire Agreement

These Terms constitute the entire agreement between you and ToraFX concerning your use of the Platform, superseding any prior agreements or understandings.
